### Congratulations on Your New Puppy!

We have made every effort to provide you with a happy, healthy puppy. Your puppy will come vaccinated to date, microchipped, and will be de-wormed on schedule. You will be given records to provide your veterinarian. Your puppy will come with a **2**-year health agreement, provided these conditions are met:

- 1) From pick up date, buyer has 72 hours to have the puppy's initial exam by a licensed veterinarian. If appointment is outside this time frame, it must be noted on this form and discussed prior to leaving. In the unlikely event your puppy is found to have a life-threatening hereditary or congenital defect at this or any exam by the age of 24 months, we will replace the puppy as soon as we have availability. You must notify us within 24 hours of exam should there be an issue. If buyer does not comply with above statement in this section, this health agreement will become null and void. The puppy must be returned within 72 hours of this notification. The puppy must be accompanied with registration papers, valid veterinarian contact information, and a written report completed by a licensed veterinarian stating that puppy has a congenital or hereditary disease not associated with environmental factors, such as, but not limited to: hernias, undescended testicles, any injuries, parasites, etc. Replacement will be subject to availability. We will provide a full refund if the puppy is returned within 72 hours of pick up date. Seller is not responsible for vet bills, travel expenses, or other acquired costs.
- 2) This agreement covers inherited or congenital diseases and does not include non-congenital illnesses, such as, but not limited to: kennel cough, Parvo, Distemper, Corona Virus, or any other contagious disease, after 48 hours of pick up date. These diseases are highly contagious and can be contracted immediately after leaving breeder.

3) Buyer must maintain health of puppy by keeping vet check-ups current as well as vaccinations. Failure to do so or inability to provide seller with records will make this agreement null and void.

4) Buyer who purchases a puppy with a limited registration will agree to spay/neuter puppy within 2 years. AKC recommends that the puppy's time frame for being spayed/neutered should be made on an individual basis and in conjunction with the veterinarian and owner. It is the responsibility of the owner to ensure that no accidental breeding occurs prior to being spayed/neutered. Buyer who purchases a puppy with full registration is not subject to spay/neuter agreement.

5) Your puppy must NEVER be surrendered to an animal shelter of any kind. We understand that traumatic life circumstances can happen and there will never be judgement if you must return the dog. We can place our dogs in loving homes at any age.
